DISCHARGE, RELEASE & INDEMNITY IN CONSIDERATION OF MOKINGJAY SKIRMISH PERMITTING THE PARTICIPANT TO PARTICIPATE IN LASER SKIRMISH AND OR ARCHERY TAG:

1.1 RULES, TERMS AND CONDITIONS:

The Participant agrees to abide by the following rules of Mokingjay Skirmish and archery tag at all times when present at the Laser/Archery Skirmish Venue.

- (a) No projectiles are to be thrown, kicked or otherwise made airborne by participants unless said projectiles are officially supplied "Archery tag safety arrows propelled by Archery bows supplied by Mokingjay skirmish.
- (b) No participant shall engage in:- •Skylarking or Reckless behaviour or Foolish behaviour or use of foul or obscene language; or •Any other behaviour likely to cause injury to Themselves or Other participants; or Employees or agents or Mokingjay Skirmish; or •Any other behaviour which Mokingjay Skirmish deems in its absolute discretion to be unacceptable.
- (c) Mokingjay Skirmish may require any participant engaging in unacceptable behaviour to leave the Laser Skirmish Venue.
- (d) Each participant must remain within the designated boundaries of the Laser Skirmish Venue at all times.
- (e) Each participant will be required to wear, Long trousers and enclosed shoes, equipment provided by Mokingjay Skirmish and all other safety devices that Mokingjay skirmish may require the participant to wear.
- (f) Any participant who is unable or refuses to comply with rule (e) will not be permitted to participate in Laser Skirmish or archery tag.

1.6 WARRANTY AS TO FITNESS
